NOW, upon the Motion of Ms. Cyganovich, it is hereby


ORDERED, that the Defendant show cause, at a special term of the Supreme Court, before the Honorable Daniel J. Doyle via Microsoft TEAMS on the 24<sup>th</sup> day of August, 2021, at 10:00 am *DDO*

or as soon thereafter as counsel can be heard, why this Court should not issue an order as follows:

- A. Compelling the Defendants and/or their agents to comply with Doctor Nussbaum's, order and prescription to administer Ivermectin to their mutual patient, Richard Cyganovich, and thereafter as ordered by Dr. Nussbaum; and
- B. Granting Ms. Cyganovich such other, further and different relief as this Court may deem just, equitable and proper; and it is further

ORDERED, that pending further order of this Court, the Defendants, their agents, and assigns, and any third parties acting on its behalf, upon receipt of this Order to Show Cause and its supporting papers, shall immediately enforce Doctor Nussbaum's, order and prescription to administer Ivermectin to their mutual patient, Richard Cyganovich, and thereafter as further ordered by Dr. Nussbaum.
