FIVE MALE MODELS FILE NEW SEXUAL MISCONDUCT LAWSUIT AGAINST PHOTOGRAPHER BRUCE WEBER

STATEMENT OF LISA BLOOM, ATTORNEY FOR PLAINTIFFS:

A year ago, we filed a sexual harassment case against fashion photographer Bruce Weber on behalf of our client Jason Boyce, who alleges that Mr. Weber sexually assaulted him on a 2014 photoshoot.

Today we filed a new federal court lawsuit on behalf of five additional men, all models, with strikingly similar allegations against Mr. Weber. The new case was filed under the federal sex trafficking law, which has recently been interpreted to prohibit "casting couch" behavior in which a powerful person sexually exploits a vulnerable job applicant for his own sexual gratification. That law has a ten year statute of limitations, so it opens the door for additional victims to step forward and seek justice.

We look forward to proving our clients' cases at trial.
