- g. the Seventeenth Cause of Action for Violation of the "Right to Privacy";
2. for an Order pursuant to CPLR §3024(b), striking scandalous and prejudicial material from the Complaint and removing the Complaint from the Court file pursuant to CPLR 3211(a)(7), in the event any causes of action against Mr. Finlay survive this motion; and
3. for such other and further relief the Court may deem just and proper.
