**Re: Restricted Transfers under Amended & Restated Note Purchase Agreement**

Ladies and Gentlemen:

Reference is made to the Amended and Restated Note Purchase Agreement dated as of July 15, 2016 (as amended and restated from time to time, the **A&R NPA**), between Energy Capital Investment S.à r.l. (the **Company**), Lumens Holdings 1, LLC (the **US Holdco**), Renewable Capital Investment 2, Sociedad Limitada (**RCI 2**), and Hudson Solar Cayman, LP (**Hudson**), as Administrative Agent, Initial Note Purchaser, and Note Holder. Capitalized terms used but not defined in this letter shall have the meanings assigned to them in the **A&R NPA**.


As you are aware, there is now and has been since July 31, 2017, a continuing Event of Default under the **A&R NPA** on account of the **Company's** failure to comply with its obligations under Section 3.5(j) of the **A&R NPA**. By correspondence dated January 22, 2019, to the **US Holdco**, the **Company**, and **RCI 2** as Obligor under the **A&R NPA** and Solar Holdings, Ltd., Sky Solar Power Ltd., and Sky International Enterprise Group Limited as Guarantors under that certain Guaranty in favor of **Hudson** made effective as of September 18, 2015, **Hudson** has accelerated all Obligations owing under the Note Purchase Documents and has made a demand for payment under the Guaranty.

We are writing to specifically remind you that the restrictions on Restricted Payments (as defined in the **A&R NPA**) set out in Section 5.2(e) of the **A&R NPA** continue to apply, and that no such Restricted Payments are permitted at any time a Default has occurred and is continuing, among other restrictions. **Hudson** reserves all of its rights with respect to any breach by the **US Holdco** of the restrictions on Restricted Payments under the **A&R NPA** together with any other breach by **US Holdco** or other Obligor under the Note Purchase Documents.
