Level Payment Plans: These are designed to allow you to make payments of equal amounts throughout the payment period. A fixed monthly payment amount is calculated over the term of the loan. This plan provides the least amount of interest accrual over the life of the loan.

Extended Repayment Plan: This payment plan is designed for borrowers with loan balances that exceed \$30,000 and those borrowers who had no outstanding balance on their loan as of October 7, 1998. The repayment term under this payment plan may be extended for up to 25 years. ACS offers a choice of either a Level or Graduated Plan under the option.

Graduated Plans: These offer lower payments during the first years of repayment with increasing monthly payments over time. A monthly payment amount is calculated over the term of the loan with the lowest payments in the first two years and highest in the last two years. Payment amounts increase at 24 month intervals during the repayment period.

Income Sensitive Plans: These plans allow monthly payments to be based on your income. Payment amounts are calculated based on your gross monthly income and are adjusted annually.

The Income Based Repayment (IBR) Plan: This plan is available to those experiencing a partial financial hardship. The IBR Plan takes into account your loan balances, income and family size. The IBR plan is granted in 12-month intervals and is recertified each year.
