**STIPULATION**  
**AND REQUEST TO SO ORDER**  
**ENLARGEMENT OF**  
**PAGE LIMITS**

This Stipulation is entered into by and between Plaintiff the People of the State of New York, by Letitia James, Attorney General of the State of New York (“Plaintiff”) and Defendant The National Rifle Association of America, Inc., (the “NRA”), through their respective counsel.

**SUBJECT TO THIS COURT’S APPROVAL, IT IS HEREBY STIPULATED AND AGREED**, by and between the Plaintiff and Defendant the NRA that:

1. Should Defendant the NRA move to dismiss Plaintiff’s Complaint, Defendant the NRA shall be permitted to file a supporting memorandum of law up to 40 pages in length.
2. In opposition to any motion to dismiss filed by Defendant the NRA, Plaintiff shall be permitted to file an opposing memorandum of law up to 40 pages in length. Plaintiff reserves the right to seek a further enlargement of the page limits applicable to its opposition papers, including the memorandum of law and accompanying affidavits.
3. For reply papers in further support of any motion to dismiss filed by Defendant the NRA, Defendant the NRA shall be permitted to file a reply memorandum of law up to 30 pages in length.

**IT IS FURTHER AGREED AND STIPULATED** that this stipulation can be executed in counterparts and by using electronic, scanned or telefaxed signatures, with the same effect as original signatures.
