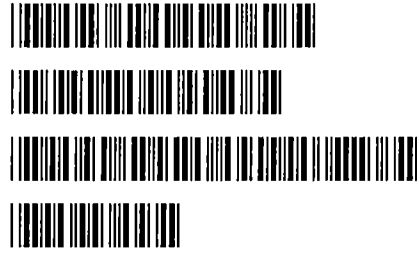




Defendant (s)

Plaintiff, by its attorneys, complaining of the defendant(s), respectfully alleges:

1. Plaintiff is licensed as a debt collector by the New York City Department of Consumer Affairs, license number 1253378.
