3. I have been admitted to practice law in the Commonwealth of Massachusetts since 2007, and am currently licensed and in good standing to practice law in that jurisdiction.



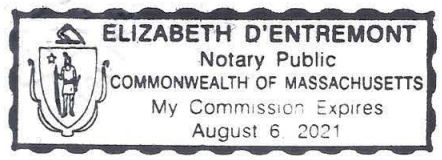

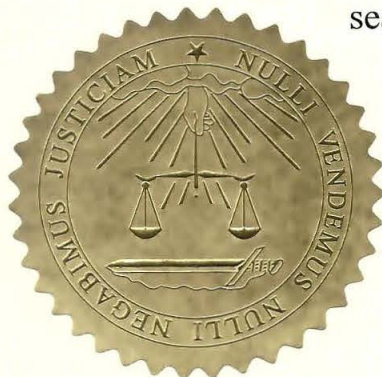
